Privacy Policy

Our Privacy Policy

PE "Nelikvid" ("We") seeks to respect the confidentiality and inviolability of personal data and other information that We receive from users of our site. In this regard, each user registered (subscribed to the mailing list) on our site is required to read this Privacy Policy (the "Policy", "Privacy Policy").

If you want to use our site (the "You", "User") (the Forum has its own rules), you must fully and unconditionally accept all the terms of this Privacy Policy before using the site. The subscription form (registration) is available for remote use through the website www.radio-detaly.com. You have the opportunity to receive mass mailings of an email to your address ("Subscriber"), in advance expressing their consent to receive these messages from Us.

1. GENERAL PROVISIONS

- 1.1. This Privacy Policy informs you of how we receive, store, process, use and protect personal information and other information received from users of the site www.radio-detaly.com.
- 1.2. By registering (by subscribing to the newsletters), you agree to the terms of this Policy and grant Us the right to receive, store, process and use Personal Data and other information that we receive with your consent.
- 1.3. To access the personalized features of the site, you need to register (subscribe to the newsletter) from us, providing us with complete and reliable information about yourself. The result of registration will be the virtual user's cabinet (subscriber) created on the site.

2. INFORMATION WE ASSEMBLE, KEEP AND PROCESS

- 2.1. The information We collect, store and process includes the contact information entered during registration (subscription) on the site (name, surname, e-mail address, website), messages at the Forum that you exchange with us or other Subscribers, and Other information contained in this Policy.
- 2.2. We receive Personal and Informational data from you via our website and e-mail, however, in some cases, We may receive this information from other persons. We collect only the information that is necessary to fulfill the goals of our relationship with you. We do not collect information that the applicable law prohibits to collect. We also do not collect information in ways prohibited by such legislation.
- 2.3. We are directly involved in the receipt of Personal and Information data, their subsequent storage, processing and use within your User's Cabinet.

3. PURPOSE OF DATA COLLECTION AND USE

- 3.1. While registering on the site, we ask you to fill out the registration form using your Personal Data. We use this information for further communication with you.
- 3.2. The purpose of collecting personal and information data is to provide you with the services that you requested. We will not use the Personal and Information data for purposes that are not related to our Services.
- 3.4. We will send you information about the prices, messages, special offers and promotions provided by Us. If you do not want to receive such information from us, please let us know by using the functions of the site or by contacting us by e-mail.
- 3.5. You cannot personally (with the help of the User's Cabinet) delete the Personal and Information data provided by you. Therefore, if you decide to cancel our services, you should ask the administrator (via chat, feedback form or e-mail) to delete your personal information.

4. TRANSMISSION OF DATA

- 4.1. We do not provide Personal and Informational data to third parties without the permission of their owner, with the exception of the following cases:
- After obtaining the consent of the owner of the Personal Data, to appropriate actions with this data, if such actions and their conditions are not regulated by this Policy.
- If you need to transfer such data to fulfill your order or request.
- If this is required to comply with applicable laws, fulfill requests and requirements of judicial, law enforcement and other state bodies.
- In the event you violate the terms of this Policy or the User Agreement, or other agreements and agreements between you and us.
- 4.2. In the case of mergers, acquisitions, purchase and sale, the change of ownership of PE Nelikvid, Personal and Information data is likely to be among the assets transferred to the new company. If this happens, we will notify you by e-mail or post this notice on our Site 10 days before such changes occur.

5. ACCESS TO THE DATA

- 5.1. You can contact us with a request to provide all of your personal information that is stored on our website. We will try to respond to such a request within 5 days.
- 5.2. If your Personal Information has changed or you no longer wish to use our site and want to delete all Personal and Information data provided by you, you can send us a request by email.
- 5.3. If your personal data stored on our website has changed, you need to make appropriate changes in the Personal Area, as using our outdated information may reduce the quality of the services you provide.

6. STORAGE AND SAFETY OF DATA

- 6.1. We will take all reasonable precautions to protect the Personal and Information data stored in the Service from loss, misrepresentation or unauthorized use. This includes physical, technological and software security measures. We are trying to protect such data from the stage of their transfer to the site.
- 6.2. However, you should understand that there is no way to transfer data over the Internet or store it digitally, which will be 100% secure. Thus, despite all our efforts, We cannot guarantee the absolute protection of information received from you. Also, if you lose or do not guarantee the safety and confidentiality of your authorization data on the site (login and password), third parties can get unauthorized access to your Personal Area, as well as to Personal and Information data stored with us.
- 6.3. We will store your Personal Information and Information as long as your Account will be active.

7. DEDICATED DATA

- 7.1. The site uses cookies and other technologies to help us monitor the actions of users of the Site. A cookie is a piece of data that is automatically created by the site and stored in the user's computer as one or more files. Cookies are individual, but do not contain any Personal Data.
- 7.2. You can block the download of the cookie to your computer at any time, however this may make certain functions of the Site inaccessible to you.
- 7.3. When using the Site, we receive and store data that does not identify a specific person and is not personal: the user's IP address, the version of the operating system, the presence or absence of installed software, the version of such software, etc. We use this information

to monitor and analyze, track the movement of users on the Site, collect demographic and geographic information about our user databases in general. We do not associate such data with personal data.

7.4. Our privacy statements set forth in this Policy do not apply to third-party cookies and We do not have access to or control over such files.

8. FINAL PROVISIONS

- 8.1. In the future, due to the expansion or modification of the functions of the Site, as well as the change in the procedure for its provision, this Privacy Policy will be amended. We will notify you of such changes in the Policy by sending a message to your email address or by placing an appropriate notice on the site.
- 8.2. All changes made to this Policy will be available in the form of its new version at https://radio-detaly.com/politika-konfedencialnosti. The new version of the Privacy Policy shall take effect no sooner than 30 days after the date of sending or posting notice. In any case, while using the Site, you agree to the terms of the Privacy Policy in the editorial office in force at the time you use the Site.
- 8.3. If you are not fully aware of the terms of this Policy, you may contact us for the clarifications you need. By registering on the site and / or accepting the terms of this Policy in another way, you confirm that you understand all the provisions of this Policy and you have received from us all the explanations you need.
- 8.4. If the provisions of different language versions of this Privacy Policy are treated differently, the version in Ukrainian will have priority.
- 8.5. To this Privacy Policy and relations between PE Nelkvid and you arising in connection with the use of the Service, the legislation of Ukraine is applied.
